From the office of Mayor Hank Williams Regarding COVID-19

April 14, 2020

As we move several weeks into the global pandemic of COVID-19, each of us is wondering how long this infectious virus might impact our daily lives, jobs, education, and social activities. The circumstances and full effect of what is happening will not be known for some time, and the unknown is a worrisome thought. However, there are things we do know, and those are the things that should continue to receive our focus.

As of yesterday, there were 47 confirmed cases of COVID-19 in Jackson County. Jackson County has done a fantastic job collaborating with local healthcare partners to give us one of the highest testing rates per capita in the United States. Although aggressive testing equates to a higher number of positive results, it remains the single-most effective way to detect and control the rate of COVID-19 infection in our community. We are fortunate to have a County and local health providers that have reacted quickly and are doing a thorough job of limiting those impacted in our community.

The past week has shown some encouraging news both nationally and locally, with the rate of COVID-19 infections, hospitalizations, and deaths slowing (curve is beginning to flatten). These positive trends are a direct result of the excellent work each of you has been doing to keep our neighbors, friends, and families safe. However, until new infections are reduced to a level that allows health experts to begin advising differently, the recommendations of Governor Brown and the Jackson Public Health Department should be followed so we may each do our part to "stop the spread." Although challenging, continuing to follow social distancing recommendations will allow our local business community to return sooner rather than later.

<u>Stay home, save lives</u>. The best way to stay healthy and prevent the spread of COVID-19 is to stay home. You must also limit things you do outside your home to what you must do. Examples of things you must do are shopping for food or picking up medicines. The Governor's order does not allow gatherings where people cannot keep 6 feet apart. Also, the order does not allow social events and non-essential business where people come into close contact.

If you must leave your home for essential activities, you should:

- 1. Maintain 6 feet between you and all other people. Wash or sanitize your hands after contact with any surface. Do not touch your face, except after washing or sanitizing your hands.
- 2. Avoid groups and contact with other people.
- 3. Wear a cloth covering for your nose and mouth to protect others if you can't keep 6 feet apart. Do so, even if you feel well and do not show symptoms of illness.
- 4. Do not place a cloth covering for the nose and mouth on children under age 2, anyone who has trouble breathing or who cannot remove the covering themselves.
- 5. Stay home if you are sick. Stay home and consult with your doctor or a clinic if you are ill with any of these symptoms:
 - Fever of 100° or higher
 - Cough
 - Shortness of breath
