## **Building Permit Cost Information**

The cost of a building permit is based upon the valuation of the construction. Valuation data is calculated based upon the ICC valuation table published April 1 of each year. In addition to a building permit, mechanical, plumbing, and electrical permits will also be issued. The Oregon Building Codes Division requires that the City of Central Point collect a 12% surcharge that is added to permits. Senate Bill 1036, passed in 2007, allows school districts to request that a tax on new construction be collected by local governments. A fee of \$1.17 per square foot for habitable space in residential construction is added to a permit, and \$0.58 per square foot for non-residential construction.

Mechanical permits are issued based upon the equipment being installed for residential construction and based upon the valuation of the mechanical construction for non-residential construction. The minimum mechanical fee is \$65.

Plumbing permits are based upon the number of bathrooms installed in new residential construction, or by the number of plumbing fixtures for remodels and non-residential construction. The minimum plumbing permit fee is \$65.

Electrical permits are based upon the square footage of the residence or upon the specific work for remodels and for non-residential construction.

Building permits will have a plan review fee of 65% of the permit fee. A plan review fee, if applicable, to non-residential mechanical, plumbing, and electrical permits may apply.
