The City has budgeted for the construction of a new traffic signal at the intersection of Beebe and Hamrick Roads. The project has been in the City's Transportation System Plan since 2008 and in original plans for the development since 1999. Warrants have been met and a signal is now warranted.

The City Budget has the project listed, but without a revenue stream to fund it. With the passage of the state transportation package the City is anticipating receiving an additional \$150,000 in funds in the 17-18 budget and \$300,000 in the 18/19 FY. If funds come in as anticipated staff will bring back a formal request to fund the project in March of 2018 with construction anticipated for Spring of 2019.

In an effort to work with the Central Point East Subdivision Public Works met with them regarding their entrance islands in the spring of 2017. After a series of meetings it was agreed that when construction would commence on the project we would move the "Central Point East" subdivision sign to landscaped area to the north of the intersection, and agree to put in the lights for it. The elimination of the island is needed in order to accommodate a designated left turn lane.

The Home Owners group requested if we could do the same thing with the island off of Meadowbrook and Biddle. Public Works agreed to do this work at the same time. Since the time of that meeting several people who live in the White Oak phase of the development have come out in opposition of eliminating the islands. They have also requested we notice all residents of Central Point East, which would also include Beebe Woods, Parkwood Village and Brookdale Gardens.

#### Hamrick-Biddle Discussion

Staff will also have discussion on options for reconfiguring the Biddle/Hamrick Signal for better turn movements and lead discussion on jurisdictional issues and Deferred Improvement Agreements associated with USF Reddaway.
