CITY OF CENTRAL POINT Multicultural Committee Minutes September 12, 2016

I. REGULAR MEETING CALLED TO ORDER

Chair Amy Sweet called the meeting to order at 6:40 p.m.

III. ROLL CALL:

Roll call: Amy Sweet, Christina Garrett, Keith Stone, Dolores Cadwallader, and Fran Settell were present. City Recorder Deanna Casey was also present. Council Member Taneea Browning arrived at 7:17 pm.

Rita Copado was absent.

IV. PUBLIC APPEARANCES AND CORRESPONDANCE

V. APPROVAL OF MINUTES

A. Approval of July 11, 2016 Committee Minutes

Fran Settell moved to approve the minutes as presented. Keith Stone seconded. All said "aye" and the motion was approved.

VI. BUSINESS

A. Medford Multicultural Fair

Chair Amy Sweet asked who would be able to attend and work a shift at the Medford Multicultural Fair. Mrs. Settell stated that she would take the first shift because she has the table and tents to set up, she will also return at the end of the day to help take down the booth. There was discussion of who would be able to work each shift. Mrs. Casey has ordered items that can be handed out.

B. MAYA Scholarship Review

There was discussion about the scholarship that is available to Crater Students. Each year the responses have been less and less. Last year there were no applicants. There was discussion regarding the criteria for the applications. Mrs. Sweet will call the schools and find out what we can do to process the applications and if the Crater Foundation would be able to help with the process.

Council Member Taneea Browning is on the review committee for the Crater Foundation and asked if the MAYA criteria would be set in stone. Students didn't feel that they had done anything close to what Martin Luther King Jr. had done in his life. The criteria is too grandiose for what they had accomplished during their time at Crater. She recommends changing some of the criteria or renaming the Scholarship.

The committee made several changes to the application. It will now be called the Central Point Multicultural Committee Scholarship. We can work with the Crater Foundation to see what they can do to help us get the word out. The Committee reworded some of the application questions to show more of a service oriented application rather than reflect Martin Luther King Jr.

C. Liaison Reports

Mr. Stone reported that there are several Polynesian events in the next few months. On November 26, 2016 there will be an Island Song Festival at the Mormon Church.

Mrs. Cadwallader reported that there will be a Latino Day of the Dead run in Talent on October 22, 2016.

Mrs. Garrett reported on the future events taking place at the Expo. Tattoo and Music Festival is September 30 through October 2nd. The RV Show will be September 12th through 25th. The Harvest/Brew Fest and Battle of the Bones will be September 16th through the 18th. Christmas Holiday Market is December 4th and the Bridal Show will be October 14th through the 16th. The Parks and Recreation Committee will be having an open house to begin work on their Master Plan process. There are several Halloween events coming up, she will make sure they are posted on the Multicultural Committee Facebook page.

Mrs. Sweet reported that the Kiwanis Club will be holding a Halloween party for kids on October 29th at Santo Community Center. The Siroptimist Club will have a Wine Walk on September 25th. This walk is for women's health. She has found a Buddhist Temple in Ashland. Dancing with the Rogue Valley Stars will be on November 12th, this event is a fund raiser for Sparrow Clubs.

Mrs. Cordeiro-Settell reported that she was able to find some local language contacts for the city to use if they need translation services. There are three German people who have agreed to be on the list of translators, and a person for Japanese, Mandarin and Cantonese. She will continue to research this need in the community. She is looking for a contact to add to the list for sign language. There will be a Salsa Festival in Medford on September 17th.

D. Community Christmas/Lights Parade

Parks Event Coordinator Cory Shaw explained the process for the Lights Parade and Community Christmas Event. The parade has a different route than in previous years. She provided the application for having a float in the parade. The city will waive the fee for this committee.

Mrs. Cordeiro-Settell stated that she is still willing to pull the flat-bed trailer behind her jeep if the rest of the committee can help decorate the day of the event. She would encourage all the families to dress up and walk alongside the float. She will be the point of contact for anyone waiting to walk beside the float.

Mrs. Garrett stated that she would be able to help set up the float. She will post an invite on our Facebook page for cultural type clubs in town to walk with us.

VII. ADDITIONAL BUSINESS

2017 Ohana Fair update

Mr. Stone updated the Committee that the Ohana fair will not happen this year but he hopes the Committee can help with the event for 2017. He has chosen September 16, 2017 for the date. The event will start at noon and go into the evening. He will be working with the City on the permit process.

Mrs. Shaw provided the special event permit application. She explained what the process and time like might look like at this point. The City is excited about having the event in Central Point but they need a clear picture of what would be required of the City. Without Council blessing we are limited to the amount of assistance we can provide.

There were several questions from the committee members regarding the event. If there are sponsors what would they be sponsoring, is the event free to the public, there would need to be liability insurance for the amount of people Mr. Stone is anticipating. There was discussion of the types of things available during the event, would there be vendors, do they pay a fee, what is the money used for if there are sponsors or a fee for vendors to attend.

Council Member Taneea Browning wanted to make sure the Multicultural Committee is in favor of this event and would be willing to help. Mr. Stone would be the main organizer with the Multicultural Committee as help. If the Committee needs to have financial assistance from the City a proposed budget request would need to be presented to the Budget Committee in March of 2017.

VIII. ADJOURNMENT

Mrs. Cordeiro-Settell moved to adjourn, Amy Sweet seconded, all said "aye" and the Multicultural Committee Meeting was adjourned at 7:55 p.m.
