

RESOLUTION NO. 1650

A RESOLUTION CANVASSING THE VOTES CAST AT  
THE GENERAL ELECTION HELD NOVEMBER 3, 2020

**Recitals**

1. A general city election was held on November 3, 2020, during which time legal voters of the City of Central Point considered the election of City officers;
2. Pursuant to state law, the Jackson County Clerk has certified the results of said election, said certification having been issued on the 23rd day of November, 2020; and
3. The City Charter requires that the City Council meet and canvass the returns of said election at the first regularly scheduled meeting following receipt of the Jackson County Clerk's certification of election results.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF CENTRAL POINT, OREGON, AS FOLLOWS:

Section 1. That the votes cast by electors of the City of Central Point for Mayor, two Councilmember At-Large positions and one Ward IV Council position, at the general election of November 3, 2020, are hereby found, determined and declared to be as follows:



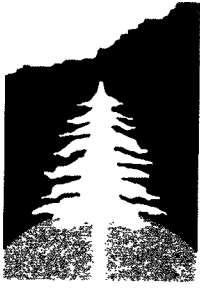
Section 3. The City Recorder is hereby directed to issue certificates of election to the persons declared elected in Section 2 above within thirty (30) days after the effective date of this resolution.


